- Agree to arrange for Flea Fumigation at the end of the tenancy & at any time during the tenancy as required or requested by the Lessor's Agent to be carried out by a Company complying with Australian Standards.
- Agree that during the tenancy, when a Routine Inspection is to be conducted, your pet/s is controlled and restrained at all times.
